To apply for replacement benefits, complete the Request for Replacement Food Purchased with SNAP Benefits form (LDSS-2291) .*

Recertifications: If you receive a Cash Assistance or SNAP recertification notice by mail or an ACCESS HRA alert that you need to recertify, you must submit your recertification or your benefits will stop. You can use ACCESS HRA, fax, mail, or a drop box at open centers to submit your recertification.*

Every month a portion of SNAP participants ordinarily must submit paperwork and complete an interview to continue receiving benefits when their certification period ends; this is called the recertification process.*

*About SNAP The District of Columbia's (District) Supplemental Nutrition Assistance Program (SNAP) (formerly known as Food Stamps) helps low-income individuals and families by providing monthly benefits to purchase food. *Do not sell, trade, or give away your SNAP benefits, or any SNAP cards or documents. Use SNAP benefits only to buy eligible items. *Most households applying for SNAP no longer have to pass a savings/resource test in order to get SNAP benefits. This means that the household's assets (stocks, savings and retirement accounts, etc.) are not considered when determining eligibility.*

*In New York State, the SNAP Program now allows you to have more money in a checking or savings account, or even a retirement account, without affecting your eligibility for SNAP benefits. As of January 1, 2008, most households applying for SNAP benefits no longer have to pass a savings/resource test in order to get SNAP benefits.*

*Calculating Benefit Amounts. SNAP expects families receiving benefits to spend 30 percent of their net income on food. Families with no net income receive the maximum benefit, which is tied to the cost of the USDA's Thrifty Food Plan (TFP), a diet plan intended to provide adequate nutrition, consistent with the Dietary Guidelines for Americans, that low-income households can purchase and ...*

*IMPORTANT!! To Login to myBenefits or to Create an Account, you MUST use a username and password created specifically for myBenefits. You cannot use an account created for another NYS application such as unemployment Insurance, Dept. of Motor Vehicles or Child Support.*

*The following apply to your SNAP account: It does not cost you to use your EBT card for SNAP transactions. You do not get cash back when you use it. You can only buy eligible food items. You may pay part in cash and part with your EBT card. You can use your EBT card if your SNAP case is closed as long as you have benefits left in your account.*
